
In 2022 we finally saw some moderation in the growing interest in boating. Transport Canada saw a huge surge in applications for Pleasure Craft Licenses and Pleasure Craft Operator Competency cards that began in 2020 and continued into 2021. 86% of the Office of Boating Safety inquiries were about Pleasure Craft Licensing.

New Boat Sales



Canada Retail New Boat Sales Units

- sales were down 12% to ~41,000
- Outboard boats made up 48% of all new retail boat sales units
- Personal Watercraft unit sales made up 31%
- Sales across all segments were down except for Jetboats which were up 5%




Used Boat Sales



Canada Pre-owned Boat Sales Units - Market share

- Sales were down 20% to ~60,000
 with sterndrives down 29%
- Outboard boats accounted for 43% of all pre-owned boat sales units
- PWC accounted for 19% of all pre-owned boat sales units and were -11%



What Happened on the Water - 2022 OPP Statistics




2022 saw 29 fatalities

Vessel Types in the Fatalities

- → Unmotorized vessels were involved in 45% of total fatalities
- → Over 50% of the fatalities occurred during cold water season

Regulatory Consultations Coming in 2023



Mandatory Life-jacket Wear

Transport Canada is expected to launch a Let's Talk Transportation consultation on mandatory life jacket wear this year. The factors that will be considered include age and vessel type and length.

Engine Cut off Switches

Transport Canada is currently seeking comments (until May 19) on their Let's Talk Transportation portal on introducing new requirements on installing and using engine cut off switches. This would apply to vessels that are less than 8m with 3Hp and up and a primary helm that isn't in an enclosed cabin. Currently only PWCs are required to use the "kill switch".

Regulatory Consultations Coming in 2023 (cont)



Pleasure Craft Licensing Regulation Modernization

Will be going to Gazette 1 this spring for the final consultation on the proposed changes. The proposed changes are limiting the PCL to a 5-year term and subject to a \$15 renewal fee.

New Vessel Operation Restriction Regulation Schedule - Wakeboarding

This spring TC will also be publishing in Gazette 1 their intention to create a new VORR schedule (7.1) for wakeboarding activities. This will potentially allow municipalities to implement restrictions on wakeboarding such as limiting it to specific areas in a lake and/or certain times.

Regulatory Consultations Coming in 2024



Decibel Coalition

The 2021 SQL survey showed 95% of respondents ranked relaxing by the water as very important. Loud boats were a major obstacle to this basic enjoyment. 67% of respondents were in favour of decibel limits.

TC has moved forward on boat noise emissions and will likely bring the proposed regulations for new and existing vessels to Gazette 1 for the final consultation towards the end of 2024.

Big thanks to the GBA membership for commenting on the **Let's Talk** proposal and writing to their MPs in support of decibel limits. Also a big thanks to the 9 Associations that joined the Decibel Coalition and made their voices heard.



2022 Ontario Forest Fire Stats






- 2022 was a very quiet fire season with 2,560 hectares burned in Ontario compared to over 793,000 hectares burned in 2021.
- In 2022 a cyclical pattern of warm weather followed by periods of significant widespread precipitation kept the fire hazard in check.







Promoting Fisheries Value of Georgian Bay



Georgian Bay's recreational fisheries play a major role in Ontario's recreational fisheries valued at over \$1.75 billion a year.

GBA fisheries report "New Recreational Fishing Regulations for FMZ 14" identified key topics:

- Protection of the fishery is vital to local towns
- Opportunities for kids and new anglers
- Methods for building fisheries for future anglers
- New rules affecting walleye and lake trout fishing, using live bait, and proposals for catch and release



Promoting Fisheries Value of Georgian Bay (con't)





Georgian Bay and North Channel's commercial fishery is part of Ontario's commercial fisheries valued at over \$377* m in revenue and 1,100 jobs mostly in smaller communities



GBA promotes ways to assist local fisheries: (see GBA report *State of Lake Huron and Georgian Bay's Commercial Fisheries* (fall 2020)



Issues Facing Fisheries and Steps to Mitigate Threats





- Slow recovery following Covid restrictions –
 commercial harvest declines 20/21 the lowest over a 10-year period.
- Jump in sea lamprey numbers in year 22/23 caused by Covid restrictions affecting lamprey controls
- Invasives continue to upset local food chains/spawning grounds/movements of fish.
- Improper use/movement of live bait spreading invasives

Issues Facing Fisheries and Steps to Mitigate Threats (con't)





- Walleye population recovery in certain areas while others continue to decline - new regulations regarding walleye stocking are expected in 2023-24
- Outdated fishing regulations affecting both the recreational and commercial fishery need for new revisions on commercial and recreational fish quotas, catch, size and seasons, including designated fish sanctuaries and restricted fishing zones.

 Continue to promote Indigenous commemorative and awareness days as well as First Nations events along the eastern and northern shore of Georgian Bay.

 Work to increase the sharing of First Nations cultural knowledge and information, including TEK with GBA members.

- GBA represents around 34,000 people based on the survey result of 11.78 people per household (average)
 - Our previous estimate was 6 people per household
 - We use a conservative 30,000 people to describe the GBA reach in communications
