### Issue and Implications

- Floating homes in Ontario have a "pending" classification as a vessel by Transport Canada.
- As a vessel they are <u>completely</u> regulated by the Canadian Shipping Act 2001. They are immune to any regulation by all ministries, agencies, and yes... municipalities have no control.
- The implications "Float Homes not Vessels" pose:
  - a) Avoid building code adherence permitting, standards, and approvals
  - b) Avoid regulatory control of location, mooring, creating navigational issues for public
  - c) Avoid shoreline works (boathouse and dock) permitting and control
  - d) Avoid assessment and municipal taxation revenues, yet they consume municipal emergency services
  - e) Avoid environmental control.... Yes, as a vessel they can locally discharge grey water

### The solution is taking shape....

As a float home not a vessel, three levels of government will be able to collaborate

- 1. At the municipal level, they will have the right to create bylaws on provincial waters within their boundaries to control and regulate floating homes.
- At the provincial level, MNRF has passed new regulations governing float homes and specifically – they are not able to "camp" overnight on provincially controlled waterways
- 3. At the federal level, Parks Canada retains control over Trent Severn Waterway and has agreed with Transport Canada that Parks Canada has control over shoreline works (docks and steel spuds)

...but we aren't there yet. Key to achieving our outcomes and mutual interests, we need to continue to advocate and petition Transport Canada to get this right

#### The Solution already exists in British Columbia

The problem is that Transport Canada got it right in 2001 in British Columbia when they declared that float homes ARE NOT VESSELS... Ontario is asking for the EXACT SAME POLICY. We have petitioned Transport Canada to reclassify both new and existing float homes within Ontario as Float Homes not Vessels.

- Municipalities, property associations and thousands of individual residents are deeply concerned by the potential damage including environmental, social, economic and public safety impact(s) unregulated float homes in Ontario can cause to our waterways, if left unregulated.
- The Ontario Government has recently consulted Ontarians on this matter and appears willing to bring these floating homes under regulation. But its hands are tied, they need your support to enact changes per the recommendation set out below.
- The problem is that in Ontario, Transport Canada classifies such structures as "vessels", while in British Columbia, Transport Canada classifies them as "float homes". <u>There is, accordingly, a lack of national consistency in Transport Canada's oversight of these structures.</u>
- As a result, in Ontario, as a "vessel", these structures are currently exempt from all forms of
  provincial and municipal oversight and regulation, including building code adherence, environmental
  protection, public safety, taxation and location management.
- In British Columbia, where Transport Canada classifies them as "float homes", these structures must conform to strict building standards and can be duly regulated by the province and municipalities to ensure environmental protection, building code adherence and use/location management.
- Once this change has been made, municipalities will be enabled to create bylaws to control float homes in a manner consistent with provincial and municipal standards.

We, the undersigned, citizens of the province of Ontario, call upon the Minister of Transport to:

Respectfully request that your Department classify both existing and new float homes within Ontario as float homes not vessels, in a manner consistent with the precedent your Department established in British Columbia in 2001.
